Re: Broadband for All legislation (SB 4)

Dear Senator Gonzalez:

We write to inform you that we support your efforts to modernize and increase the California Advanced Services Fund (CASF) with your legislation, SB 4. Californians across the state have suffered during the pandemic due to a lack of access or insufficiently robust access to the Internet that has made remote work and remote education a significant challenge.

Current law has failed to meet this challenge because it discriminates against local community bidders to build broadband infrastructure, favors slow outdated infrastructure with state money, does not cover all rural and low income Californians, and has been under funded. A recent report by EdSource found that California, despite having CASF already, has the tragic record having the largest number of students in the United States that lack sufficient access to broadband.<sup>1</sup>

We strongly support SB 4 provisions as it would remedy these shortfalls and create a program that will put a date certain on ending the digital divide with the following changes:

- 1) Stabilize and expand California's Internet infrastructure program (CASF) and allow the state to invest \$100s of million on broadband infrastructure every year until the digital divide is closed.
- 2) Enable local governments to bond finance more than \$1 billion with state support to secure long-term low interest funding to build local infrastructure.
- Build broadband networks that meet the Governor's Executive Order's goals with an emphasis on scalability to ensure future proofing in infrastructure financed by the state to ensure access is built to last for the 21<sup>st</sup> century.
- 4) Enable local public entities to deliver 21<sup>st</sup> century infrastructure for low-income neighborhoods that lack broadband access.
- 5) Expand eligibility for state support to all rural Californian communities.

Broadband is a service as essential as water and electricity making it more critical than ever to rethink the status quo and invest in long term solutions that will address the multiple emergencies facing our state. The current deployment and availability of broadband infrastructure has failed countless millions of California families in our cities and rural communities. The time has come to make the long-term investments to secure access to education, healthcare, jobs, and government services for all communities. The time to invest is now.
