RE: Senate Bill 418 (Padilla) – Support As Amended May 18, 2023

Dear Assembly Member Villapudua:

On behalf of the Rural County Representatives of California (RCRC), we support SB 418, authored by Senator Padilla (D-San Diego). This measure would establish the California Prison Redevelopment Commission and task it with developing recommendations that will repurpose closed state prison facilities into community assets. RCRC represents 40 of California's rural counties and the RCRC Board is made up of one locally-elected Supervisor from each member county.

Several of our member counties are home to California Department of Corrections and Rehabilitation (CDCR) facilities. Recently, CDCR announced the planned closure of the Chuckawalla Valley State Prison located in the City of Blythe. Compounded with the closure of the California Correctional Center located in Susanville in June of this year, rural communities stand to lose critical jobs and economic drivers, particularly when prison closures are not paired with reasonable plans to redevelop the closed facilities. Without the recognition of the economic importance these facilities provide and with no clear direction from the State, local jurisdictions will struggle to keep workers and their families, which further weakens areas that are already disadvantaged.

SB 418 recognizes the need for this pairing of closures and long-term planning, which will lead to thoughtful considerations of the impact of prison facility closures statewide. RCRC appreciates that the measure would utilize the Governor's Office of Business and Economic Development to oversee this new commission, as the problem is one of economic development and not incarceration. Furthermore, we appreciate the need to incorporate the feedback of communities impacted by prison closures, as they stand to lose the most of a thoughtful approach is not utilized. This process can still maintain the State's objectives in reducing incarceration without jeopardizing jobs and communities as a byproduct.
