RE: Senate Bill 707 – Support As Amended May 23, 2023

Dear Senator Newman:

On behalf of the Rural County Representatives of California (RCRC), we are pleased to support your Senate Bill 707, regarding textile recycling. RCRC is an association of forty rural California counties and the RCRC Board of Directors is comprised of elected supervisors from each of those member counties.

Senate Bill 707 requires textile manufacturers to establish stewardship organizations for the collection, transportation, and recycling of used textiles that are no longer suitable for reuse by consumers. Importantly, SB 707 ensures that consumers throughout the state – including rural areas - will have convenient access to free takeback and recycling opportunities.

Local governments are already strained with implementing other aspects of solid waste recycling and disposal programs. Counties are under constant pressure to increase solid waste diversion to achieve the state's goal to divert 75% of solid waste from landfill disposal. As such we believe that SB 707 appropriately extends responsibility for end-of-life recycling of textiles to the manufacturers who introduce those products into the marketplace.

Textiles like apparels, towels, linens, sheets, drapes, mats, tablecloths, napkins, and fabric are commonly disposed and make up a substantial portion of the commercial and residential waste streams. When goods are over-produced, they often end up in the waste stream where they can be difficult to manage. Currently, a manufacturer's obligation to address these issues ends once the product is introduced into the marketplace, where the burden for managing the materials is shifted to local governments and solid waste enterprises. SB 707 requires textile manufacturers to develop programs to facilitate the recovery and recycling of textiles, thereby helping local governments and

the state increase recycling, reduce disposal levels, and relieve taxpayers of the burdens of funding those actions.

Finally, RCRC appreciates that SB 707 allows entities like local solid waste facilities and transfer stations to participate in local collection efforts and be reimbursed the costs of managing those items by the stewardship organization.
